What is OPEN Enrollment

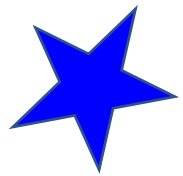
Allows employees who are eligible to enroll themselves and/or eligible dependents in a health, dental or vision plan when they have not done so previously or at the time of a qualifying event.

What is SWITCH Enrollment

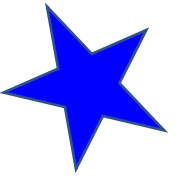
Allows current NMPSIA members to switch medical or dental plans if they choose to.*

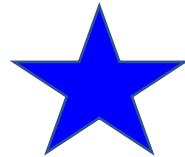

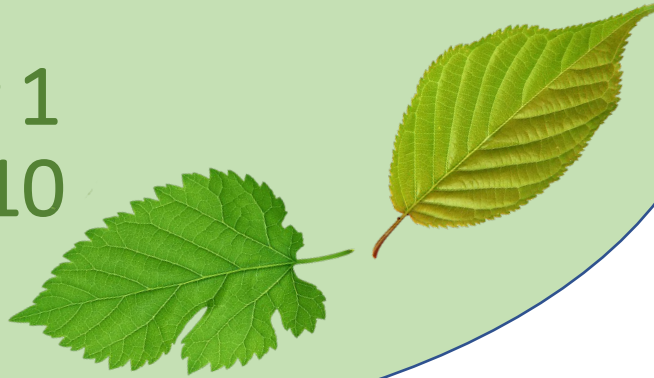

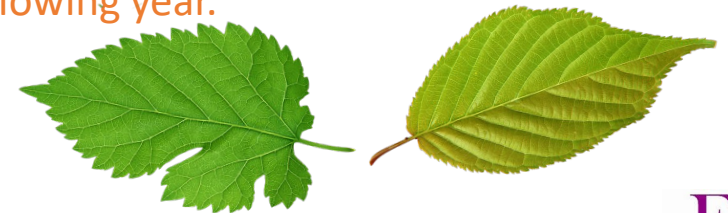
