In addition, the team is constantly reviewing trends in school risk management issues. As a result they work closely with NMPSIA to develop programs to curb those trends, such as the Technical Assistance Program (TAPS) a partnership with CES, Pecos Valley REC, and NMPSIA to provide an IDEA hot line and professional development training.

Team Members are specialized in areas such as Human Resources, Ergonomics, Threat Assessment, Active shooter, Site Security Design, Security Drill analysis, Playground Inspections, Safety and Security, Identifying a School Predator, Loss Control and Risk Management.
